Booth Spaces & Fees:

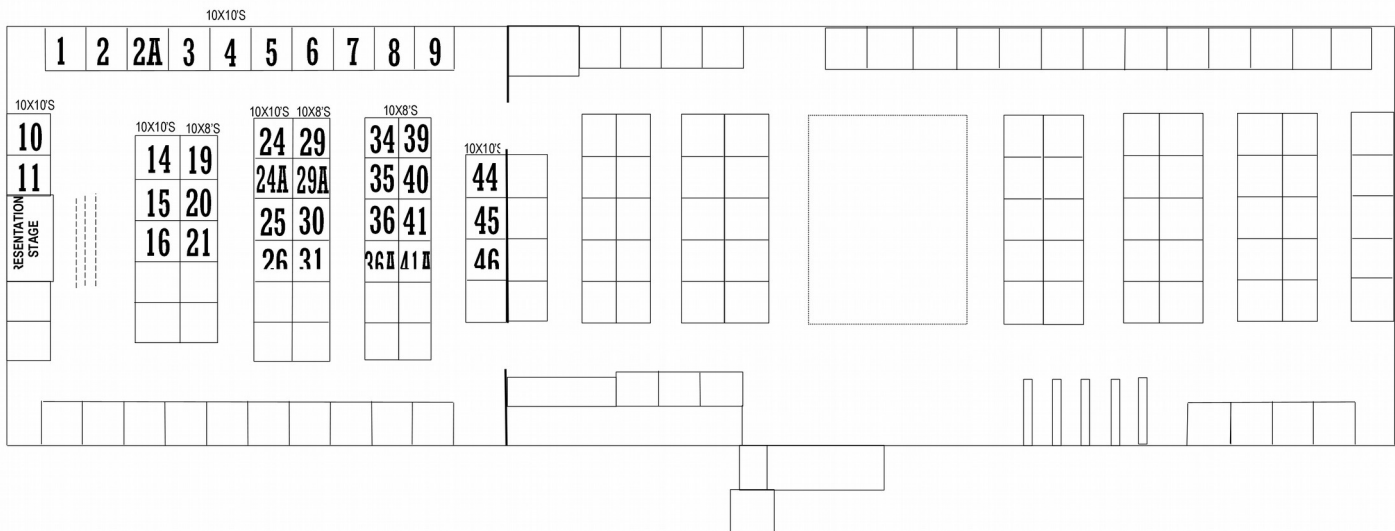
- 8'x10' - \$325 For multiple booths, double or triple fee. Booth fee goes up to \$375 after Feb. 10
- 10'X10' - \$375 For multiple booths, double or triple fee. Booth fee goes up to \$425 after Feb. 10
- Corner Space guarantee: add \$50
- Outdoor Space 10'X10' - \$260 Booth fee goes up to \$325 after Feb. 10
- Space assignments are made on a first come first served basis when payment is received in full. Requests for the same space as last year cannot be guaranteed although special consideration is given to last year's exhibitors who register and pay in full by Feb. 1. If you have a preference, list first, second and third choice under Special Requests.
- See floor plan below. Space numbers may be different than last year.
- Pipe and drape backdrops will be provided. All exhibit materials must be confined to the booth space assigned. No fliers or promotional materials are to be hung up, displayed or distributed outside of your designated booth area.
- Certificate of Insurance is required. Space reservation is not guaranteed until a certificate of insurance is received.

Set Up Info:

- Time: Friday, March 1 from 12 to 6 p.m. and Saturday, March 2 from 7 to 9:30 a.m.
- Large setups requiring use of overhead garage doors for access or forklift for set up must be set up by noon on Friday, March 1. The garage doors will be blocked after 12 noon. Garage door openings are 12' high. There will be a forklift and driver available on Friday morning from 8 am to noon only if requested. Please specify on contract if you need to use the garage door access or forklift.

Tear Down:

- After 5 p.m. on Sunday. All booth materials must be removed from the building by 9 p.m.
